**A RESOLUTION ESTABLISHING PUBLIC SAFETY AGENCIES AND  
AREAS**

**WHEREAS**, the Board of Supervisors of East Fallowfield Township is responsible under the Second Class Township Code for the public safety of the residents of East Fallowfield Township; and

**WHEREAS**, the Board of Commissioners of the County of Chester has requested that East Fallowfield Township provide the Board of Commissioners with a resolution outlining the methods and agencies chosen to fulfill the public safety needs of East Fallowfield Township for the efficient administration of the emergency communications system of the Chester County Department of Emergency Services.

**NOW, THEREFORE, BE IT RESOLVED** the Modena Fire Company will provide fire and EMS services; the Westwood Fire Company and Divisions thereof will provide fire, rescue, EMS services, to include Advanced Life Support services. All areas and emergency responses will be set forth as appropriate by the Fire Chief of the Modena Fire Company or Westwood Fire Company or his/her designee(s) in the areas defined by Exhibit A, attached hereto

**FURTHER, IT BE RESOLVED** that the East Fallowfield Township Police Department will provide police protection for the entire Township of East Fallowfield;

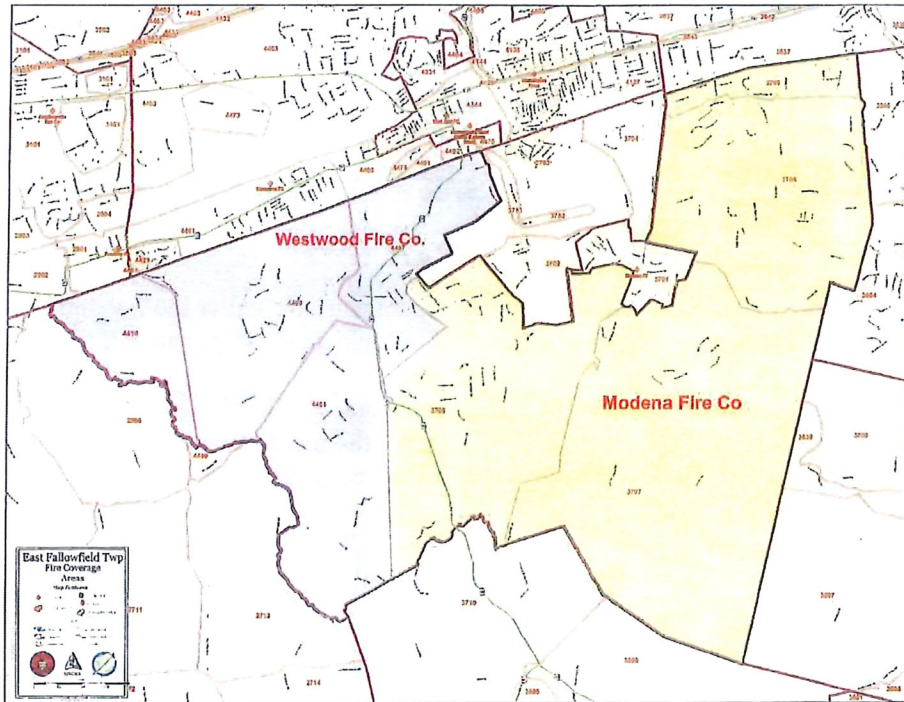
