The plan proposes to construct a new wireless communications facility located at 775 Fairview Road. The facility will consist of a fenced yard with equipment cabinets and a 140-foot tall lattice tower. The new tower will replace the existing outdated 140-foot tall lattice tower currently on the site. Two (2) new equipment shelters are proposed for AT&T and Verizon. Access to the facility will be from the existing gravel driveway. The site is located in the RA Rural Agricultural Zoning District. No water or sewer service is proposed for the site.

The proposed facility has received Conditional Use approval and Zoning Hearing Board approval as applicable. The plans and documents have been revised in accordance with Township recommendations and the comments in my previous letters.

The following comments are offered for your consideration:


Conditional Use Decision and Order

- 1.1 Condition #7 – The applicant is required to provide the necessary financial security in an amount to cover the cost of disassembly, demolition and removal of the facility and in a form acceptable to the Township Solicitor. The applicant has submitted three (3) estimates for each of the providers and for Tower Economics. The estimates have been reviewed and the amounts are acceptable.
- 1.2 Condition #10 – The legal descriptions for the easements have been revised and are now acceptable. The easements and recordable documents must also be reviewed by the Solicitor.

All other outstanding items have been addressed. The plans are now in proper order for approval.
