1. Call to order, silent meditation, and pledge of allegiance.

2. DISCUSSION

A. Election of Temporary Chairman to start the meeting.

Mike Crotty took nominations for election of a Temporary Chairman for the Reorganizational meeting.

<u>MOTION:</u> Randy Doan made a motion to appoint Mr. Steven Herzog as the Temporary Chairman to start the January 3, 2017 Reorganizational meeting. Wilson Lambert seconded.

B. Election of Chairman.

<u>MOTION:</u> Randy Doan made a motion to appoint Mr. Steven Herzog as the 2017 Board of Supervisors Chairman, Wilson Lambert seconded.

VOTE: 3-0

C. Election of Vice Chairman.

<u>MOTION:</u> Randy Doan made a motion to appoint Mr. Edward Porter as the 2017 Board of Supervisors Vice Chairman. Steve Herzog seconded.

VOTE: 3-0

D. Appointment of Township Solicitor.

<u>MOTION:</u> Steve Herzog made a motion to appoint the firm of Siana, Bellwoar & McAndrew, LLP, for the 2017 year at the rate of \$195.00 per hour for general municipal legal services and paralegal services at \$120.00 per hour. Randy Doan seconded.

QUESTIONS AND COMMENTS:

1) Sharon Scott commented that she was disappointed when Mr. Crotty gave a prior report and identified a property as the Johnston Farm. She stated that property has not been the Johnston Farm for 10-15 years. The property should have been identified properly. Mike Crotty clarified that the name Johnston Lot 2 was the name on the subdivision and land development plans and that name was identified by the Township Engineer and Zoning Officer in consideration for approval of a stormwater management agreement. Mike Crotty stated the property was known by the Township as the Johnston Lot 2 Subdivision and Land Development and that was the name the plans were submitted to the Township with. She said it should be identified as the Denny Howell Development.

E. Legal.

1) Notice Only – Bawa Conditional Use Hearing – Next Hearing Scheduled for 1-17-17.

Mike Crotty announced that the next Bawa M. Fellowship Conditional Use Hearing is scheduled for January 17, 2017 at 6:00 pm.

2) Notice Only – 2017 Bidding Thresholds Established by the State.

Mike Crotty stated right before year end, the State announced new bidding thresholds which are as follows:

- a. No formal or written bid process required under \$10,700.
- b. Written/phone quotes required greater than \$10,700, but less than \$19,700.
- c. Formal bidding required \$19,700 or greater.
- F. Township Secretary and Township Right to Know Officer.

Mr. Rhoades commented on past Township treasurers working part-time for years and the Township has not grown that much to support the need for a full-time treasurer. Mr. Rhoades commented that a lot of the billing for the Township is currently being contracted out.
