East Fallowfield Township Improves its Budget Format

This summer East Fallowfield Township's finance department created new QuickBooks accounts using the DCED (Department of Community and Economic Development) Chart of Accounts as the framework. "This format provides uniformity of account numbers and titles across department budgets and operating funds," said East Fallowfield Township's Finance Officer, Pani Martin.

"Having the correct income and expense codes is crucial for tracking and accurately monitoring expenses, and provides the Board of Supervisors, administration, and Township residents with a clear picture of how the Township allocates resources for its program of service delivery," said Martin.

The DCED established this numbering system so all municipalities are able to report in a consistent and similar way. "By seeing the breakout of something as simple as building permits, our governing body will be able to interpret how our community is growing," concluded Martin.

A Brief History of Zoning in Pennsylvania

Zoning is, at its core, the municipal regulation of the use of land. Today, a municipality regulates the use of land by implementing a zoning ordinance. However, as far back as the 18th century, land use regulations were enacted in Pennsylvania. Early land use regulations in Pennsylvania and elsewhere were generally concerned with preventing the spread of fires. For example, an act was adopted in the 1700s that prohibited baking and barrel making except in shops or places built of masonry. After the Revolutionary War, a law was adopted that prohibited storing more than 30 pounds of gunpowder within two miles of Philadelphia. The concept of setbacks (i.e., the required distance between a structure and a property line) was implemented to provide for adequate distances between buildings to prevent the spread of fires.

Lower Merion Township was the first municipality in Pennsylvania to adopt a zoning ordinance. Although, the ordinance was subsequently challenged, and the Superior Court found in 1925 that the Township did not have the authority to adopt the ordinance. In the Euclid case decided the following year, the United States Supreme Court held that zoning is a constitutional exercise of the police power.

The police power is a concept that is central to zoning. It is an inherent power of the state to protect and promote the public health, safety, morals and general welfare. Most zoning laws, however, are enacted at the municipal level rather than the state level. Accordingly, states delegate the authority to regulate the use of land – a police power – to municipalities through zoning enabling acts since municipalities only have the powers granted to them by the state. In Pennsylvania, the enabling statute that gives municipalities the authority to regulate the use of land is the Pennsylvania Municipalities Planning Code (MPC). The MPC was enacted in 1968 and authorizes municipalities across Pennsylvania to adopt zoning ordinances for the purposes set forth in the MPC. However, not all municipalities in Pennsylvania have adopted a zoning ordinance.



Pennsylvania has 67 counties and 2,561 municipalities. According to the Pennsylvania Department of Community and Economic Development (DCED), as of 2015 approximately 68% of all municipalities in Pennsylvania had zoning regulations. Of the 1,739 municipalities with zoning, 137 of those municipalities had not adopted their own zoning ordinance and were under a county zoning ordinance. That left 822 municipalities without any zoning regulations. Municipalities without zoning tend to be more rural, less developed and less populated than municipalities with zoning. DCED found that as of 2015, 98.2% of Pennsylvania's urban population was zoned while only 68.9% of the rural population was zoned.

Although the number of municipalities in Pennsylvania that have adopted zoning ordinances in the fifty years since the enactment of the MPC is somewhat surprising, there is no expectation that the municipal regulation of land will decrease. Rather, it is expected that the municipal regulation of the use of land will only continue to increase and become more extensive.

Westwood Fire Company Receives \$50,000 Grant for Energy Efficiency Upgrades

The Westwood Fire Company which serves a portion of East Fallowfield Township, received a \$50,000 grant from the Pennsylvania Department of Community and Economic Development (DCED) over the summer.

"State Senator John Rafferty was instrumental in helping the Fire Company receive the grant," said Westwood Fire Company's Assistant Fire Chief John Sly. The grant will provide funding to replace the outdated lighting in the fire station with energy efficient LED lighting. "These upgrades will provide a long-term cost-savings to the Fire Company by reducing electrical expenses," said Assistant Chief Sly.

East Fallowfield Township's two fire companies, Modena Fire Company and Westwood Fire Company, receive financial assistance from the Township. However, they also rely heavily on state grant support and the generous donations of local residents. "In addition to responding to emergencies throughout the community, both fire companies are also involved in active fundraising to raise money for firefighting equipment and training resources," said Chief Sly.



East Fallowfield Township Police Department takes another major step forward in police transparency with In-Car Camera System

In an effort to continue to increase police transparency and accountability, The East Fallowfield Township Police Department recently upgraded several of its patrol vehicles with in-car camera technology from Watch Guard. The in-car camera system will provide an audio and video recording of all officer traffic stops and other interactions with the public involving patrol vehicles.

"We have successfully used technology to improve the overall quality of policing and public safety in East Fallowfield Township," said Police Chief Chris Porter. "The Digital In-Car Camera System is another tool that can improve officer safety, accountability, enhance training, and improve prosecution of criminal cases," said Chief Porter.

Some of the features of the in-car camera system include



a forward-facing camera and second wide-angle camera installed to capture activity in the back seat. These cameras can provide color images and have the ability to zoom and auto-focus.

The in-car camera is a valuable tool for the East Fallowfield Township Police Department to reassure the public that when they come into contact with police officers that the rights of each party are respected and preserved. "These recordings also help to eliminate he-said-she-said accounts of an incident and provide an unbiased account of events," said Chief Porter.

"We strive to provide high-quality, consistent services to the public, and these in-car cameras will help us continue to build trust between our officers and the community," concluded Chief Porter.

Please do not feed feral cats or wild animals!

East Fallowfield Township has been receiving numerous complaints about problems associated with an increase in feral cats within area neighborhoods. Feral cats are unneutered strays that live in the wild and are considered to be free-roaming or community cats. **Please do not feed feral cats** unless you intend to take responsibility for their overall care by spaying/neutering them or providing vaccinations.

These animals are a nuisance to your neighbors and are very likely not vaccinated against rabies. They can be a danger to you and your pets! Much of the cause of the growing feral cat community is created by well-intended residents who regularly put out food for wandering cats. They don't understand that helping a few cats in the short-term leads to MANY more cats with the same needs in the future. This kind of feeding makes the problem worse and is ill-advised.

While East Fallowfield Township is currently evaluating

how to address the feral cat problem, we urge you to visit the Human Society website (www.humansociety.org) for more information. You can also review the tips below to learn more about what you can do to help outdoor cats:

- If you want to know how you can help community (feral and stray) cats, go to the Humane Society website: http://www.humansociety.org/issues/feral_cats/
- If you have been letting your cats outside, make them safe, happy indoor cats who only go out when supervised on a harness and leash, or in a safe enclosure.
- If you know people who let their cats outside, explain to them why it's safer to keep cats inside.

East Fallowfield Township Moves Forward with Development of an “Official Map”

This summer, the East Fallowfield Planning Commission and an Official Map Task Force worked together on East Fallowfield Township’s Official Map. The Official Map will show the locations of planned future public lands and transportation facilities, recreational parks, trails, sewer infrastructure, and open space.

The proposed map and an associated ordinance would allow the Township to articulate its long-term goals for particular properties, such as turning a privately-owned farm into a park or open space. “It’s a great planning tool,” said Township Manager Scott Swichar. “Unless the property owner agrees to dedicate or donate the mapped land to the municipality, the municipality must work with the property owner to purchase or acquire an easement to use the land,” said Swichar. “The Official Map would give East Fallowfield Township first dibs on acquiring a property for public use before a property owner decides to build or develop,” he said.

The East Fallowfield Planning Commission also presented a draft of the Township’s ‘Official Map’ to the community and Board of Supervisors at a public hearing over the summer.



“Official Maps are a combined map and ordinance, and East Fallowfield Township’s Official Map will be one of the methods used to implement the goals and objectives set forth in the 2015 Comprehensive Plan,” said John Nielsen, Vice Chairman of the Township’s Planning Commission. “Official Maps are also a planning tool authorized by Article IV of the Pennsylvania Municipalities Planning Code,” he said.

To develop the Official Map for the community, The East Fallowfield Board of Supervisors retained the services of a professional land use consulting firm, Ray Ott & Associates. The Township also received a Vision Partnership Grant from the Chester County Planning Commission last year to fund the project. The Board of Supervisors will consider adopting the Township’s Official Map Ordinance and Official Map at a public meeting on Tuesday, October 23 at 6:30PM. The community is encouraged to attend and offer their comments. The proposed Official Map can be viewed electronically at the following website: <http://eastfallowfield.org/2015pdf/EFTOfficialMap.pdf> or seen at the East Fallowfield Township Building located at 2264 Strasburg Road on Monday- Friday between the hours of 8:00AM and 4:00PM.

East Fallowfield Township’s 2018 Road Paving Program Moving Forward

East Fallowfield Township is making significant progress in meeting the Road Maintenance Program goal to provide excellent street conditions throughout the Township.

At the June 2018 Board of Supervisor’s Meeting, the Board of Supervisors awarded the 2018 Road Paving project to Longs Asphalt, Inc. in the amount of \$241,302.20. In 2018, East Fallowfield Township will pave another seven roads in need of resurfacing. “The selection process was very difficult, but winter weather left its mark on those seven roads in need of immediate attention,” said Scott Swichar, East Fallowfield’s Township Manager.

East Fallowfield Township Surveys Residents on Trash/Recycling Collection

East Fallowfield Township requested customer feedback from residential trash customers in the Township via a six-question online survey that was conducted over the summer. More than 500 residents replied to the online survey through SurveyMonkey. The survey results will help to guide the Township's administration in the development of a new trash and recycling collection contract that will begin in January 2019.

"The East Fallowfield Board of Supervisors is committed to developing more effective ways of delivering services and programs to our residents," said Board of Supervisors Chairman, Steven Herzog. "The survey was developed to help the Township's administration and Board of Supervisors better learn what trash and recycling services are important to residents of East Fallowfield Township," said Herzog.

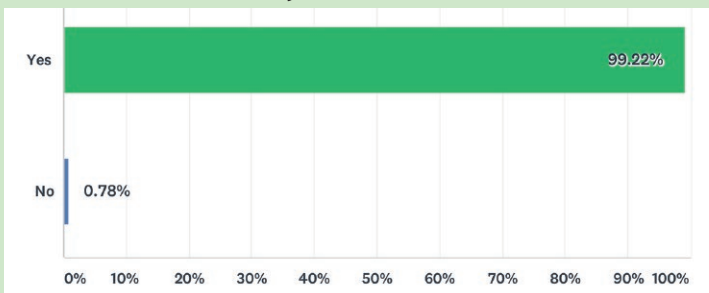
Overall the results of the survey were positive and residents shared excellent feedback about their experiences. While 74.63% of residents were very satisfied or satisfied with the current trash and recycling program in the Township, a large percentage of residents were also interested in obtaining a larger recycling bin or increasing the frequency of recycling collection from every other week to once a week.

East Fallowfield Township Trash and Recycling Satisfaction Survey

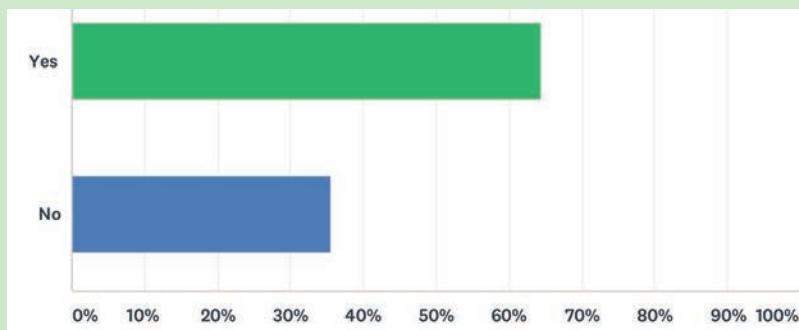
Q1 Are you a resident of East Fallowfield Township, Chester County?

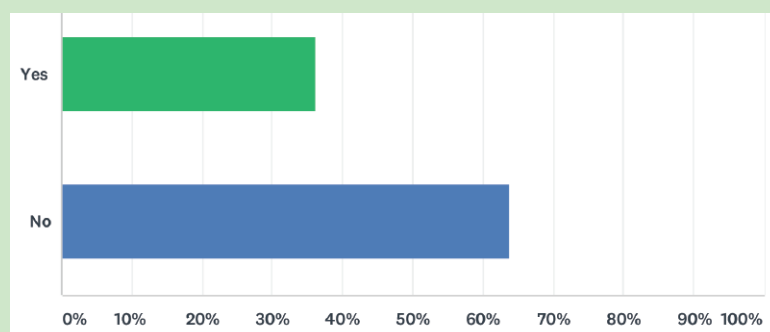
Q2 Currently recycling is picked up every other week. Would you prefer recycling be picked up every week?

Q3 Currently Bulk item collection is once/month. Would you prefer that bulk items be collected more than once/month?

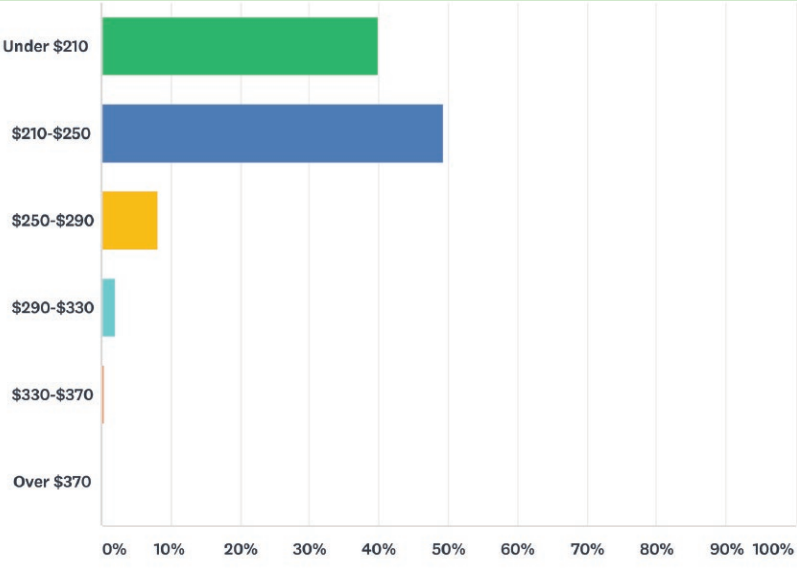

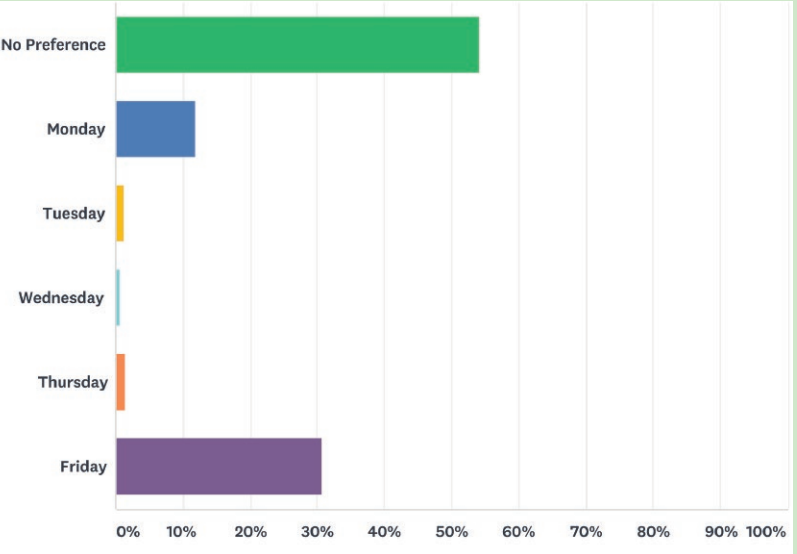

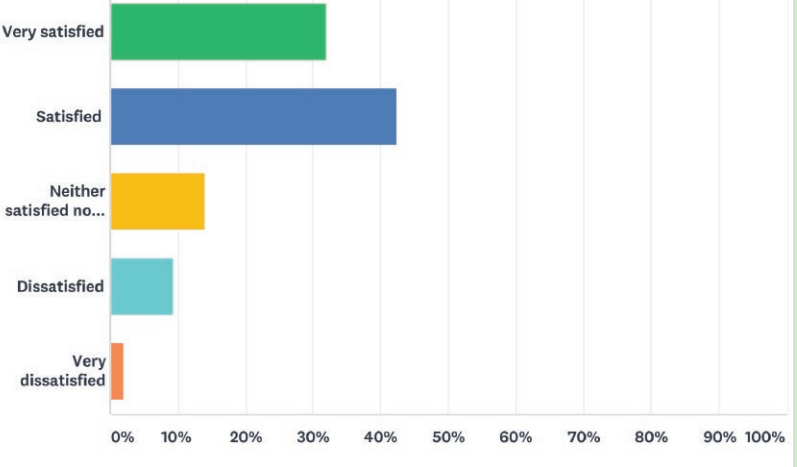

Reducing Stormwater and Flooding

What You Can do to Help

- Disconnect your rain gutters (downspouts) from impervious surfaces (such as driveways and sidewalks) and direct the flow to grassed areas or into infiltration beds (dry wells).
- Install a rain barrel and use the collected rainwater for watering flowers and gardens.
- Allow a buffer of native grasses and other vegetation to grow along streams, ponds, or wetlands. This will filter pollutants, protect the stream channel and bank from erosion, and provide better habitat for aquatic based animals.
- Convert small low-lying areas into rain gardens. These can consist of small gardens of water tolerant plants and bushes that will help retain and infiltrate runoff.
- One of the best ways you can reduce the impacts of stormwater is to reduce the pollutants that can be carried in runoff into streams, reservoirs and water supply intakes. Always properly dispose of household hazardous waste, including cleaning solutions, paints, oils, batteries, solvents, pesticides, sealants, fertilizers, etc. When applying fertilizers or pesticides to your lawn or garden, only apply the recommended amount, and do not apply just before a rainstorm, or near a water body.
