## EAST FALLOWFIELD TOWNSHIP CHESTER COUNTY, PENNSYLVANIA

## **RESOLUTION 2010-10**

WHEREAS, the Board of Supervisors of the Township of East Fallowfield has established a trash collection and recycling program; and

WHEREAS, the Township has an established program of enforcement that periodically monitors participation, receives complaints and issues warnings for required participants of both the trash collection and recycling program; addresses illegal dumping and littering problems; and provides for the issuance of fines and penalties; and

WHEREAS, it is the desire of the Board of Supervisors of the Township of East Fallowfield to formalize its recycling, illegal dumping and littering enforcement programs and to designate and appoint a recycling coordinator to act on behalf of the Township in administration and enforcement of these programs.

**NOW, THEREFORE BE IT RESOLVED THAT** by the Board of Supervisors of the Township of East Fallowfield as follows:

- Section 1. Pursuant to Section 20-106 of the East Fallowfield Township Code of Ordinances, the Board of Supervisors hereby resolves to designate and appoint the Public Works Director as recycling coordinator who shall be responsible for recycling data collection and reporting, and for the coordination of enforcement efforts under the trash collection and recycling program including but not limited to monitoring participation, receipt of complaints, issuance of warnings, and monitoring and addressing illegal dumping and littering problems.
- Section 2. The Board further resolves to delegate to the said recycling coordinator the duty and authority to act on behalf of the Township in administration and enforcement of Chapter 20, Part I, including but not limited to, the issuance of citations and appearances before the magistrate district judge under Section 20-107 of the Code.
- Section 3. The recycling coordinator shall monitor compliance on a daily basis. Upon a finding of a violation, the recycling coordinator shall issue either a written warning or a citation, in his discretion. Following the issuance of three written warnings for the same violation, the recycling coordinator shall, at a minimum, issue a citation. Nothing in this policy shall limit the authority of the Township to undertake any available legal remedy as may be appropriate on a case by case basis.
- <u>Section 4.</u> Pursuant to Section 20-103.4 of the Code, the Board hereby designates the following materials as recyclable trash: clear glass, colored glass, aluminum, steel and bimetallic cans, high-grade office paper, newspaper, corrugated paper and plastics.

**BE IT FURTHER RESOLVED** that this Resolution shall be effective immediately upon adoption.
