

POLICE DEPARTMENT

September 2007- Monthly Report

SUMMARY:

As of September 30, 2007, there were 2,857 incidents dispatched. In 2006 during the same period, there were 2,455 incidents, and in 2005, there were 2,394 incidents. So far this year there has been an increase of 402 incidents over the same period last year.

In addition, we began coverage in the Borough of Modena on June 1, 2007 and handled 165 incidents there from June 1, 2007 to September 30, 2007.

In September 2007, our police officers handled 388 incidents in East Fallowfield Township and 28 incidents in the Borough of Modena. These incident totals <u>do not</u> reflect all the traffic stops generated while conducting speed enforcement details.

K-9 team was assigned to containment on the rear while two ofcs. attempted to make contact with the suspect. There was no response. Entry was made and while ofcs. were searching the first floor the suspect exited the basement, was detained by the K-9 team, and arrested by ofcs. A sheriff's deputy also served a civil court order on the suspect, and he was transported to District Court to be arraigned by Judge Gill. Bail was set at \$ 5000.00 at 10% and the suspect was released after he posted bail.

		valve so it could not be tampered with. Ofcs. attempted to further search
		the residence but found it to be too unsafe. Modena Borough officials were
		notified and have followed up with corrective actions.
