## Terms & Conditions:

**Application:** Application must be completed and submitted with a copy of your insurance and Food Handler's License, Proposed Menu and the fee of \$75 by Friday, September 3, 2021. Applicants will be notified via email of participation status. Please send check or money order for \$75 to East Fallowfield Township, C/O Concert in the Park, 2264 Strasburg Road, East Fallowfield, PA 19320.

**Set Up:** Trucks will be able to being set up at 12:00 noon on the day of the event. Participants must be in their designated spot no later than 30 minutes before the start of event. Required inspections will occur before the beginning of the event at 2:00 PM. All food trucks are required to have a fire extinguisher on premise. Trucks must be self-contained and keep all extra materials out of sight.

**Utilities:** Trucks must be self-sufficient. There is no electric or water supplied or available onsite. Trash receptacles will be present.

**Clean Up:** All vendors must clean their designated spot of all debris/trash. Spots requiring clean up after the event could result in exclusion from future events. All vendors will be let out thirty minutes after the event has completed to allow for crowds to disperse and all public safe exit.

**Inclement Weather:** The rain date for Park Day will be held on Sunday, October 3, 2021. There are no refunds.

**Reminder:** Food Vendors must have a Food Handlers License and Liability Insurance in order to secure a vendor spot. It is the responsibility of the Food Vendor to register with the Chester County Health Department and submit appropriate paperwork to us prior to the event.
