**SIGNIFICANT EVENTS:**

01/01/08 0336/0447	Valley Township	ASSIST/BARRICADE/SHOTS: Valley PD requested assistance with a barricaded suspect, shots fired. An EF officer responded along with multiple officers from other departments. A perimeter was established and Comm #1 and the WCCERT was requested. While assistance was enroute the suspect came out unarmed and was taken into custody without incident. The rifle was recovered.
01/05/08 0046/0659	700 block of Doe Run Road	TSTOP: Motorist was stopped for driving north in the south bound lane. When an officer approached the driver's side of the vehicle he observed 4 subjects in the vehicle that were all displaying signs of a Hispanic street gang. He also observed a white powder on the center console and a cigar tube filled with it. Ofc did try to obtain driver's info but the 19-year-old driver advised Ofc. that he did not have a license and Ofc. observed that the driver was intoxicated. Ofc. requested back up due to the violent nature of the gang and knowing that they do carry weapons. Ofcs. responded from Coatesville PD & South Coatesville PD. All four subjects were taken into custody with out incident and several knives were found on the subjects. All four subjects were transported to Coatesville PD to be identified through Livescan, fingerprints and photographs. One minor subject was cited for underage. One juvenile was cited for underage. The driver was arrested for Driving under the influence at this time. The fourth passenger who was over the age of 21 was arrested for furnishing alcohol to minors. The white powder will be sent out for testing at the PSP Lima Lab. The juvenile was transported to New Garden TWP and released to his brother.
01/09/08 1211/1239	Township	WARRANT: Coatesville PD Narcotics requested that we attempt to serve an arrest warrant on a suspect wanted for felony drug violations. Ofcs. responded to the suspect's home. He initially refused to answer the door until an ofc. made contact through a partially open window and told him to go to the front door. He was placed him under arrest w/o incident. He was transported to Coatesville PD and released to detectives.
01/09/08 2254/0156	Township	911H/U&DOMESTIC: DES reported receiving a 911 hang-up that was busy on call back. Ofcs. did respond and found it to have been a domestic, an argument between mother and her 19 year old emotionally disturbed daughter. While Ofcs. were on location the daughter became very agitated, jumped up and choked

Ofcs. assisted with setting up the crime scene. There were two separate shootings within minutes of each other. One victim took a POV to the hospital and one was transported by ambulance.</p>
<p>01/24/08 1623/1717</p>	<p>Triple Fresh Market</p>	<p>REPORT: SCPD advised that a suspect was out at the market's parking lot with a stolen Bobcat loader on a trailer. Both were stolen from Cecil County, Md. and were related to the above incident. Ofcs. responded and witnesses reported that the suspect entered the store when he saw the PD. Ofcs. located him inside and took him into custody w/o incident. He was transported to the station and detained for ID. He had two outstanding traffic warrants from ChesCo but the constable was unavailable to serve them. The suspect was released pending investigation by Cecil County. The stolen equipment was released to the owner. See the Crime Report.</p>

Ofc. contacted Jennersville Hospital ER and advised that the subject had escaped while undergoing medical treatment. Ofc. transported the subject to Jennersville Hospital. When the Ofc. arrived at the hospital the subject stated he had stolen a vehicle from the hospital parking lot earlier in the evening to make his escape. Upon investigation Ofc. were able to locate the vehicle in EF twp and transported the owner, a nursing supervisor, back to recover it. The owner of the vehicle notified PSP-A who responded and spoke with the subject who did admit taking the vehicle. Subject was then taken into custody and will be charged by troopers.
