

**EAST FALLOWFIELD TOWNSHIP  
CHESTER COUNTY, PENNSYLVANIA  
RESOLUTION 2020-16**

Resolved by the Board of Supervisors of East Fallowfield Township, Chester County, Pennsylvania,  
WHEREAS, the Board of Supervisors of East Fallowfield Township, Chester County, Pennsylvania,  
pursuant to Article XXXII of the Second Class Township Code, 53 P.S. §§68201 et seq., has the  
power to levy taxes upon all real property within the township made taxable for township purposes.

NOW, THEREFORE, the Board of Supervisors of East Fallowfield Township hereby resolves as  
follows:

Section 1. **Real Property Tax**

The Board of Supervisors of East Fallowfield Township hereby resolves that a real property  
tax shall be levied and collected, commencing the effective date of this Resolution, at the  
following millage, on the assessed value of all taxable real estate in the Township of East  
Fallowfield, which rates shall remain in place, from year to year, except as modified by further  
resolution of the Township Board of Supervisors:

- a) The tax rate for **general purposes** (per Section 3205(a)(1) of the Second Class Township  
Code) is established at the tax rate of 2.00 mills on each dollar of assessed valuation, or, in  
other words, at the rate of no dollars and twenty cents (20¢) upon each one hundred dollars  
(\$100.00) of assessed valuation of taxable property;
- b) The tax rate for **fire protection purposes** (per Section 3205(a)(4) of the Second Class  
Township Code) is established at the tax rate of 0.56 mill on each dollar of assessed value,  
or, in other words, at the rate of no dollars and five point six cents (5.6¢) upon each one  
hundred dollars (\$100.00) of assessed valuation of taxable property;
- c) The tax rate for **ambulance, rescue and other emergency services purposes** (per Section  
3205(a)(8) of the Second Class Township Code) is established at the tax rate of 0.44 mill  
on each dollar of assessed value, or, in other words, at the rate of no dollars and four point  
four cents (4.4¢) upon each one hundred dollars (\$100.00) of assessed valuation of taxable  
property.

This total rate of taxation is 0 dollars and 30.0 cents on each one hundred (\$100) of assessed  
valuation of taxable property.

Section 2. **Severability**


The provisions of this resolution are severable and, if any section, clause, sentence, part or provision is determined to be illegal, invalid or unconstitutional, such determination will not affect or impair any of the remaining sections, clauses, sentences, parts of provisions of this resolution. It is declared to be the intent of this Township that this resolution would have been adopted even if any such illegal, invalid or unconstitutional section, clause, sentence, part or provision had not been included in this resolution.


Section 3. **Repeal**
