**RESOLUTION NO. 2023-08**

**AN RESOLUTION OF EAST FALLOWFIELD TOWNSHIP AUTHORIZING THE  
EXECUTION OF AN INTERGOVERNMENTAL COOPERATION AGREEMENT  
BETWEEN THE TOWNSHIP AND THE BOROUGH OF PARKESBURG FOR  
CERTAIN POLICE SERVICES.**

**AND NOW**, this 24th day of January 2023, BE IT RESOLVED by the Board of Supervisors of East Fallowfield Township as follows:

Section 1. Authorization of Agreement

The Board of Supervisors of East Fallowfield Township hereby authorizes the execution of an Intergovernmental Cooperation Agreement (“Agreement”) between East Fallowfield Township and the Borough of Parkesburg, attached hereto as Exhibit A, whereby the Borough will authorize the Township Police Department’s use of certain facilities, as set forth in the Agreement.

Section 2. Purposes and Objectives of Agreement

It shall be the purpose and objective of the Agreement to authorize the East Fallowfield Township Police Department to utilize certain facilities owned and operated by the Borough of Parkesburg Police Department, as set forth in the attached.

Section 3. Term of Agreement

The term of the Agreement shall be for five (5) years, commencing January 31, 2023 and concluding January 31, 2028, subject for modification and termination as set forth in the Agreement.

Section 4. Financing of the Agreement

East Fallowfield Township shall remit payment to the Borough for the services set forth in the Agreement on an annual basis.

Section 5. Organizational Structure

Each municipality shall maintain all organizational control and supervision over its own Police Department, acting through its Chief of Police. No employee or elected official of either municipality shall be deemed to be directing, giving orders to, or in any way

controlling the other municipality or its Police Department by operation of the Agreement or in carrying out the terms thereof.

Section 6. Disposition of Property

All vehicles, equipment and property of the Borough of Parkesburg and used under the Agreement shall remain the property of such Borough. All police personnel employed by each municipality shall remain the employees of such municipality.

Section 7. Severability


If any sentence, clause, section, or part of this Resolution is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution. It is hereby declared as the intent of the Board of Supervisors of East Fallowfield Township that this Resolution would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section, or part thereof not been included herein.

Section 8. Effective Date

This Resolution shall take effect immediately.
