**A RESOLUTION OF THE EAST FALLOWFIELD TOWNSHIP BOARD
OF SUPERVISORS CONFIRMING THE ADOPTION AND APPROVING
A PROPOSAL TO MAKE AN ADDITION TO THE EAST
FALLOWFIELD TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA
AGRICULTURAL SECURITY AREA.**

WHEREAS, a proposal has been submitted to the East Fallowfield Township Board of Supervisors for the review of the East Fallowfield Township, Chester County Pennsylvania Agricultural Security Area in accordance with the provisions of the “Agricultural Area Security Law”, Act of June 30, 1981, P.L. 128, No. 43, §2, and all revisions of the said statute through Act 14 of 2001 (the “Act”), true and correct copies of which are attached hereto and made a part hereof (the “Proposal”); and

WHEREAS, the Proposal includes the following owner, parcels, and acreage within East Fallowfield Township, Chester County, Pennsylvania.

NOW, THEREFORE, BE IT RESOLVED, and it is hereby resolved, that the Proposal is hereby approved and the present Resolution, the Proposal and a description of the subject East Fallowfield Township, Chester County, Pennsylvania Agricultural Security Area addition shall be filed forthwith in the Office of the Recorder of Deeds of Chester County, Pennsylvania, with the East Fallowfield Township, Chester County; Pennsylvania Planning Commission and the Chester County, Pennsylvania Planning Commission, and with the Chester County Agricultural Land Preservation Office.
