- 1. Al Wright called the April 6th meeting to order at 6:37pm.

 - m. The vendors must contact EFT to fill out the forms.
 - n. If a vendor cannot attend they can donate to the raffle. Pet Smart will provide a basket.
 - o. The Park and Rec board will each out to more vendors to get a group of core vendors signed up by April 17th.
