## Park and Recreation Commission Regularly Scheduled Meeting March 1, 2011 Approved Meeting Minutes

## A. Old Business

- 1. Meeting Minutes
  - a. JBo made a motion to approve minutes from the January 4, 2010 meeting. JBe seconds. Motion passes unanimously.
  - b. (There were no February 2011 minutes because meeting was canceled due to snow)
- 2. BOS Meeting
  - a. Michael McClintock was approved as a member of East Fallowfield Park & Recreation Commission. One Supervisor questioned whether there had been a background check. It was reported that there have never been checks done in the past and there was none done this time.

  - a. Mark Toth is compiling a newsletter for the Township. All P&R contributions should be sent to Michael McClintock by March 24 for editing, and to Mr. Toth by March 31.
  - b. JBo suggested adding P&R updates to the Township Facebook.
- 6. Portable Toilet Enclosure
  - a. The scout that was planning to build the enclosure as his Eagle Scout project will no longer be able to proceed with the project. This project idea will now be added to the P&R project "wish list"
- 7. 2011 P&R Budget
  - a. JBo will check on status of payment to HalfAcre Signs for temporary signs (No Skating, Keep Out).

a. Poison Ivy Removal near the pond and other park items needing attention will be discussed during a P&R Park Walk on Saturday, March 12 at 10am.
